This permit, if issued pursuant to the applicant's representation of lot size, location of construction, property lines, etc is subject to change, suspension or revocation if additional information should disclose that the sketch or plan provided hereto is incorrect or inaccurate.

This permit is issued based upon the information provided by the applicant. The conclusion of the building inspector is that the Fryeburg Land Use Ordinance has been compiled with, and/or based upon action of the Board of Appeals and the Planning Board, but does not necessarily represent all permits and approvals which may be required such as Department of Environmental Protection, or plumbing permits, or private approvals or permissions such as from subdivision lot owners associations, which shall be the responsibility of applicant to procure. Failure to procure and abide by all required municipal and state permits shall be grounds for suspensions or revocation of this permit.

In accepting the issuance of this permit, applicants and applicant's agents agree that the building inspector, local plumbing inspector, health officer and other municipal officials may enter the premises during construction, and upon completion of construction at all reasonable hours, without requirement of advance notice or permission, for purposes of inspecting to ensure compliance with the terms of this permit and the Fryeburg Land Use Ordinance and the State Plumbing Code.

- Driveway Entrance Permit, required for new development and/or change in use of properties accessing Routes 5, 302, 113, Fish Street, and Harbor Road
- Flood Hazard Development permit, if required
- Copy of DEP permit, if required
- Written Erosion and Sedimentation Plan, required for work in the Shoreland Zone
- Proof of payment of Mobile Home Sales Tax/Bill of Sale
- Notice of Intent to Install an Expanded Wastewater Disposal System (Form HHE-234), required for expansion resulting in increased wastewater flow
- Request for Review of Subsurface Wastewater Disposal System Design (Form HHE-614), required for new, expanded, or replacement systems serving a licensed establishment. Approval from DHHS is required prior to the LPI issuing a permit.
