Kingsbury called the meeting to order and declared a quorum.

Department Head reports: Chief Mick stated they will make Pine St accessible for tractor trailer trucks during fair to prevent traffic congestion.

Klinepeter made a motion to approve the August 25, 2022 Meeting Minutes, seconded by Tyrrell and passed unanimously.

Klinepeter made a motion to approve the 2022 Municipal Valuation Return, seconded by Tyrrell. Clarke reiterated her opinion properties are under assessed, passed unanimously.

Kingsbury opened the discussion on Public Forum. Clarke disagrees with draft policy presented. There was debate back and forth about the policy and rules of procedure. Chair should be able to run meeting how they feel is best. Clarke made motion not to adopt this policy and re-write according to suggestions. Clarke made motion to table, second by Kingsbury passed unanimously.

Clarke made a motion to accept a Subway gift card donated by Mark Lopez for the Fryeburg Police Department, seconded by Tyrrell, passed unanimously.

Klinepeter made a motion to accept a \$100.00 donation from IAFA for the Fryeburg Police Department, seconded by Clarke, passed unanimously.

Haley provided her Town Managers Report. Transfer Station stickers are now in, tax bills have been sent, first half taxes due October 15th. Audit will be taking place the week of September 19th. Clarke asked about the Senior Exemption. Klinepeter made motion to accept the report, seconded by Clarke passed unanimously.

Other Business: Clarke would like to take a minute to recognize the passing of Queen Elizabeth. Klinepeter said the post on the Rail trail is pushed way down and part of the Rail Trail is getting bad (about 60-70 feet of it) and is wondering about seeing the cost to take care and fix it. Klinepeter spoke about getting attacked by Pitbull on Main Street while walking. He is worried about school kids walking by same location. Clarke state Pitbull are a dangerous breed. 62 percent of all fatalities are from Pitbull's. Owners need to always have them under control or restraint. Kingsbury notes the new truck is at the Transfer Station.

Public Forum: Vincent Carbone stood up, Kingsbury explained to him he has 5 minutes, and we are not discussing Public Engagement. Carbone asked why not, Kingsbury explained they have discussed this at the last 4 meetings. Carbone said he wants to talk about badge 8. Kingsbury

explained that personnel issues are not discussed at Select Board meetings. Carbone was asked to leave after argument back and forth. Carbone escorted out by Fryeburg Police Department.

Daymond asked for a copy of the draft about Public Forum. Clarke explained we are just trying to figure out a way to get the Public Forum to run more smoothly. Daymond also asked how Klinepeter got the Pitbull's off. Klinepeter stated good citizens assisted.

Clarke made motion to approve Payroll Warrants and Accounts Payable, second by Tyrrell passed unanimously.

Clarke made motion to adjourn at 6:34 pm second by Klinepeter, passed unanimously.
