Selectman Eastman called the Selectmen's Meeting to order and declared a quorum. Richard Murray was absent. A Moment of Silence was taken for former President George Bush.

Selectman Eastman led the Pledge of Allegiance.

Motion made by Selectman Eastman, second by Selectman Kingsbury to approve the Selectmen's Meeting minutes of November 8, 2018. Vote 4-0.

Public Works Director Clyde Watson reported a broken windshield in the loader. The wreaths were put up. Ten sets of replacement lights were purchased and 14 sets installed. Mathew Jensen was hired to fill the open full-time position. They had a very busy 3 weeks of snow storms. Selectman Kingsbury asked if there was an increase in the price of salt this year. The cost is actually lower than last year. We contract with AVCOG for pricing.

Fire Chief Andy Dufresne's report for November is attached to the minutes.

Selectman Kingsbury asked to discuss the procedure for Committee and Board appointments. Selectman Kingsbury stated anyone requesting to be appointed to a board or committee should be in attendance when the Selectmen voted to appoint them. A motion was made by Selectman Kingsbury and seconded to require any appointees to be present when the appointment was brought to the Selectmen. Vote 2-1-1. Motion failed. It was left that this would be optional and they could be asked to attend.

Selectman Eastman recognized Mountain View Tree Farm, Josh & Krystal Johnson having a new business in Fryeburg.

Motion by Selectman Eastman, second by Selectman Clarke, to appoint Kelly Woitko to the position of Registrar of Voters effective until January 1, 2021. Vote 4-0.

Motion by Selectman Eastman, second by Selectman Kingsbury, to appoint Theresa to the position of Deputy Registrar of Voters effective until January 1, 2021. Vote 4-0.

Motion by Selectman Eastman, second by Selectman Klinepeter to approve a Municipal Quitclaim Deed without Covenants to Nancy Morris for Map 22 Lot 22-B01. Vote 4-0.

Motion by Selectman Eastman, second by Selectman Kingsbury to approve a Municipal Quitclaim Deed without Covenants to Albert Labonte for Map 41, Lot 47 property location. Vote ~~4-0~~ 3-1

Motion by Selectman Klinepeter, second by Selectman Clarke to accept Tom Rebmann's resignation from the C. A. Snow School Committee. Vote 4-0.

Motion by Selectman Eastman, second by Selectman Kingsbury to accept the Town Manager's Report. Vote 4-0.

Other business as appropriate.

Selectman Clarke asked about upgrading the Town web site and asking this to be a budget item. We should be looking at sidewalk plowing and security at the town office.

Motion by Selectman Eastman, second by Selectman Kingsbury to approve Accounts Payable Warrants #43, #45, #47, #49 and Payroll Warrant #42, #44, #46, #48. Vote 4-0.

Motion by Selectman Eastman, second by Selectman Klinepeter to adjourn at 6:53 PM. Vote 4-0.
