4. New Business:

- a. Motion by Selectman Eastman, second by Selectman Klinepeter to approve the Selectmen's Meeting minutes of October 25, 2018. Vote 5-0.
- b. Motion by Selectman Clarke, second by Selectman Klinepeter to appoint Nels Liljedahl to the Conservation Committee through June 30, 2019. Vote 4-1.
- c. Motion by Selectman Eastman, second by Selectman Clarke to approve the Resolution and Certification to be a member on the C. A. Snow School Committee. Vote 3-2.
- d. Motion by Selectman Eastman, second by Selectman Kingsbury to have Jon Bliss survey the Library and Old Registry of Deeds property and each pay half of the \$2,600 bill. Vote 3-2.
- e. Motion by Selectman Klinepeter, second by Selectman Murray to accept a podium built by Gay Kiseman for the Police department. Vote 5-0.
- f. Police Chief Potvin reported on the following:
 - Ads have been posted for a full-time police officer. They are partnering with Dollar General for Christmas. They collected 55 pounds of unused prescription that was turned in the Federal DEA. On the morning of November 8th there was another incident with a cruiser and deer. Selectman Kingsbury thank the Chief for playing Monster Mash on the cruisers during Halloween to keep the kids alert.
- g. Clyde Watson, PWD reported on the following:
 - The public works department is shorthanded right now. They installed 2 bollards on the sides of the public sand shed to keep vehicles from hitting the sides of the building.
