- **Article 1.** To elect a moderator to preside at said meeting to vote by written ballot.
- Article 2. To see if the Town will vote to authorize the Select Board to renew a lease with the Fryeburg Historical Society for use of the Old Town Hall for up to five (5) years upon such terms as the Select Board shall deem appropriate.
- **Article 3.** To see if the Town will vote enact an Ordinance entitled Town of Fryeburg Street Opening Ordinance?
- Article 4. To see if the Town of Fryeburg will vote to change its plan for its eligible police officers and firefighters effective December 1, 2021, for future service only. The Town agrees to:

Provide Special Plan 1N to its police officers and firefighters who work more than 20 hours per week and who are not temporary or seasonal as defined by the appendix to MainePERS Rule Chapter 802 for service rendered after November 30, 2021. Service for police officers and firefighters rendered before December 1, 2021 remains under Regular Plan AN; and to authorize Katie Haley, Town Manager to sign the Amended Agreement between the Town and the Maine Public Employees Retirement System.

- Article 5. To see if the Town of Fryeburg will vote to adopt the provisions of 5 M.R.S. § 18252-C (PL 2021, Chapter 286) as allowed by MainePERS Rule Chapter 803. The Town agrees: To adopt the provisions of 5 M.R.S. §18252-C as enacted by PL 2021, Chapter 286 as allowed by MainePERS Rule Chapter 803 for its non-participating employees with optional membership who previously declined to participate in MainePERS ("eligible employees") and to comply with the following requirements:
 - To offer by November 1, 2021 the opportunity to join MainePERS prospectively to all its eligible employees who have been employed for 5 years or more, to advise these employees that this will be their only opportunity to join, and to provide MainePERS with documentation of each eligible employee's election; and
 - Beginning in 2022, to annually offer eligible employees who have been employed for less than 5 years, and in 2022 eligible employees who had reached 5 years of employment between November 1, 2021 and November 1, 2022, the opportunity to join MainePERS on a prospective basis during an open enrollment period from September 1st through November 1st and to provide MainePERS with documentation of each election made by eligible employees under this provision: and
 - To withhold employee contributions for employees who join under this provision
 after all taxes have been withheld, and to remit them to MainePERS as after-tax
 contributions.

To authorize Katie Haley, Town Manager to sign the Amended Agreement between the Employer and the Maine Public Employees Retirement System.
